About E- auction, transferring the Right to organize charge,  
vehicle parking in General and Special places in the area  
of Kutaisi Municipality

E-auction is announced by Kutaisi Municipality for parking vehicles in General and Special places by transferring the right to organize charge, in a lot of places specified in the Annex:

- A. The initial annual fee for transferring the right to organize charge for vehicles parking in a lot in General and special places is 683 000.00 /six hundred and eighty thousand/ Gel.
- B. The advanced payment is 204 900.00/ two hundred and four thousand nine hundred/ Gel.
- C. Bid is determined as 20.000/ twenty thousand/ Gel
- D. as a result of the fixed final auction price, each of the 5(five) calendar years shall be increased according to the inflation index published by the national Bank in the amount of the active compound annual growth rate of over 5 (five) years, respectively.
- E. The Right transferring period for organizing the vehicle parking in general and Special places is defined by 10(ten) years.

**Rules and Conditions for participating in the Auction**

1. The recipient of the Self-Governing Kutaisi City Property via auction may be physical or legal person or group of persons of Georgia, whose property of the state and/or local authority participation in the share is less than 25%.
2. Obligations for participation in the e-auction:
  - a. Register on the website (physical and legal persons registered as resident and non- resident) after which he is assigned the status of auction participant.
  - b. Introducing the rules of e-auction during the registration and giving e-confirmation.
  - c. The advanced payment on desired Lots by the user is available via plastic card, as well as the activation of an unconditional and irrevocable bank guarantee.
  - d. Forms of payment for Lots are available for consumers on auction site. These forms contain information about the payer, Lot (lot of final bidding price) and the recipient, mentioning the name and account/account numbers. The user selects one of the reports, prints the form of the payment and on the basis of the mentioned form pay the appropriate amount of money in the bank institutions.
  - e. While paying via plastic card the price of the Lot and the advanced payment are available for the user. The Above mentioned forms contain information about the payer, Lot,( Lot of final bidding price), and the recipient, mentioning the name and account/account numbers. In case of the accuracy of data, the user presses the payment button and therefore transfers on the credit card payment system, where he complements the credit card date and carries out the payment.
  - f. Electronic auction winner is obliged to pay the final price of the property within the period specified under the terms of the auction, but in case of conditional auction, the conditions should be paid in the specified period of time.
  - g. Those participants who could not have won the auction, the deposit or a bank guarantee will be returned from the date of an auction no later than 7 (seven) banking days. Deposit will be refunded to the account from which the payment occurred.
3. E-auction will be conducted online.

4. The Bid process of e-auction can be seen online.
5. The beginning time of e- auction is considered to be the start time mentioned in the Lot.
6. Bidder, who wants to start trading from the initial price, adds price online (that means fixed adding the bid to the initial price), which is also fixed online. Betting continues until one of the parties fix the highest price. The property of Self-Governing Kutaisi City is considered to be sold/ transferred to usefulness of participating in the auction, by which at the date of completion of the online trade will be offered the highest price.
7. 7. If during the last 2 minutes of the auction the new price is offered, then the price offering time will continue from completion within 2 minutes. If the new price is offered during that time, the time will continue for 2 minutes until the final payment is fixed. but if the new price is not offered for 2 minutes, the auction winner will be the person, who offers the final amount of money.
8. In the end of the auction via e-way( e-mail, SMS), the participants will be sent the information about the auction results, that will be considered for the winner as an official notification and about Georgian Law “Local Self- Government Property”, Article 194, 1st paragraph- specified as the promise of administration body.

9. The Winner of Self Governing City – should implement the organization of the parking of vehicles in the area of Kutaisi City, According to 2013, 25<sup>th</sup> of September N225 Resolution of Kutaisi City Council “ Self Governing City – in the area of Kutaisi car parking regulation standards, to define car parking places and rules“.

10. Self-Governing City - in the area of Kutaisi the general and special places of car parking, transferring the Right to organize charge, to arrange an agreement with the winner of the auction and from Self-Governing City Kutaisi to cease the agreement unilaterally is regulated by the Kutaisi City Council 2013, 25<sup>th</sup> of September, N225 Resolution “Self Governing City – in the area of Kutaisi car parking regulation standards, to define car parking places and rules “.

11. Other issues related to the transferring the organizing right and ceasing the agreement according to the auction rule, which isn't provided by the Kutaisi City Council 2013, 25<sup>th</sup> of September N225 approved Resolution “In the area of Self Governing City Kutaisi regulation standards of vehicle parking, to define car parking places and rules” is regulated by the Georgian Civil Code.

12. The winner of the auction for the organization of general and special vehicle parking places should pay the fee for each quarterly, seven (7) calendar days in advance before the quarter ends. The winner has a right to pay total amount of the fee. The fee will be paid in accordance with the contract between Kutaisi City Municipality and the Winner.

13. The recipient who has right to organize General and special places for car parking, no more than 6 months should provide the vehicle parking places for general and special Amenities ( to draw, to install signs and informational boards and to regulate parking areas for road infrastructure). According to the contract requirements the organizer after completion of works and activities should inform Kutaisi City Municipality by written document. The recipient, before implementation the above mentioned works and activities doesn't affect contractual penalties (Subscribing of administrative fees, blocking the wheels of the vehicle and to taking to the free parking ).

14. According to the Code of Administrative Offenses 239 Article, in accordance with paragraph 27, the winner of the auction, will be granted by the same code 125 article, 8<sup>th</sup> section provided to fill the statement of the administrative offenses. The amount of the fine will be paid in accordance with the contract between the auction winner and Kutaisi city Municipality.

15. If in the duration of the contract will be settled that boundaries of Kutaisi City Municipality should increase or reduce , then the contract should be in accordance with the increased or reduced borders. According to the changes of Kutaisi City Municipality Boundaries or to the agglomeration principles in case of necessity of adding new general and special places, the fee for the vehicle parking areas should be defined by the final cost / price which will be summed by the proportional calculation, according to the territorial zones and divided space.

16. The winner who owns the rights for parking management, for parking organization is obliged:

- a) To provide targeted usage of parking places;
- b) To provide preparation of infrastructure; particularly: draw the road signs, install the information boards and road signs (liable to penalty parking placement, information on cars' blockage, parking only for disabled persons, parking only for taxes and special transport, general parking, information on parking fees and obligatory signs and boards installation);
- c) To provide sanitary-hygienic environment at parking, in order of which the owner is obliged to pay the fees for wastes;
- d) To impose control over the rules of stopping cars at parking;
- e) To impose the fees for usage of parking and define the fee amount in accordance with Kutaisi Municipality City Council;
- f) To provide parking inspectors and mobile groups assignment, training and supply with uniforms and other identification equipments;
- g) To provide illegally parked cars' blockage and/or moving them to the penalty parking place (the places defined for general, special and disabled persons);
- h) To check the penalty in case of parking rules violation and non-payment of the parking bill.
- i) Foundation of information center (hot line) during 3 months after signing the contract, which will provide citizens' acknowledgement with parking rules, privileges, payment conditions and information about blocked or moved cars to special parking area;
- j) To start society acknowledgement campaign, aiming to inform civilians about new parking system and bills for Kutaisi Municipality civilians. Above mentioned campaign implies distribution of flyers in the streets, TV and radio advertisements/announcements that should continue at least for 6 months from signing the contract;
- k) In coordination with Kutaisi Municipality City Hall, to set one special parking for penalized transport placement, disposal of which will be executed in accordance of acting legislation;
- l) To provide utilization of existing technology systems such as: scratch cards, cellular system of parking, meters with monitors, the timers installed on sidewalks – agreed with Kutaisi Municipality City Hall, in accordance with legislation of Georgia. It may be offered different means of payment, such as mobile phones, parking electro tickets, subscriber cards of different validation and etc. New technology system must be innovative and coincide with international standards. The winner is able to pay for parking with electric fast payment system, various banking system channels and other practical means. The above mentioned requirements must be implemented no later than 3 months after signing the contract;
- m) The winner must equip with special devices for payment ("fast payment" device among them) at general and special parking places around 50 meters area, agreed with Kutaisi municipality City Hall;
- n) According to the agreement with Kutaisi municipality City Hall, to install observing video equipments at parking area (100 units);
- o) According to the agreement with Kutaisi municipality City Hall the winner must equip parking places with appropriate infrastructure for disabled persons;

17. The winner must provide following activities during contract validation, concerning parking places maintenance:

- a) Information boards and signs regular update according to acting legislation and in case of physical damage;
- b) Road surface and selective works regular rehabilitation at general and special parking places borders;
- c) Immediate replacement of stolen or damaged parking payment devices;
- d) Information center functioning during 24 hours regime;
- e) Implement various obligations considered by parking management rights;
- f) To provide full execution of above mentioned rules;

18. Force majeure and urgent necessity cases will be regulated according to paragraphs considered with contract, prescribed by law.
